Peabody Awards Consideration Release

In exchange for the opportunity to be considered for a Peabody Award, the undersigned entrant company/organization (“Entrant”) hereby grants the Board of Regents of the University System of Georgia, by and on behalf of the University of Georgia Peabody Awards (“Peabody Organization”) a non-exclusive right and license to use the program listed in this application and other materials provided by or on behalf of Entrant in connection with its entry (collectively, the “Submission”), for Peabody Awards judging (including via password protected streaming), and for permanent storage in the Peabody Awards Collection archive (collectively, the “Permitted Uses”), in all platforms and in all media now known or hereafter devised. Permitted Uses shall also include the right to use clips from the Submission in the Peabody Awards Ceremony, Peabody Awards Show (including the production and distribution thereof), and otherwise in furtherance of the Peabody Organization’s Mission, and in the advertising and promotion of any of the foregoing. The Peabody Organization is under no obligation to use the Submission for any of the Permitted Uses. Nothing herein shall limit the Peabody Organization’s rights as a member of the general public.

As used herein the “Peabody Organization’s Mission” means the educational and not-for-profit purposes of invigorating people through the transformative power of stories that matter, that engage viewers as citizens, and that teach, expand our horizons, defend the public interest, or encourage empathy with others. The Peabody Organization’s Mission is pursued via publicity and outreach activities such as press releases, video news conferences, lectures, webcasts, panels, podcasts, touring exhibitions, and social media.

Entrant represents and warrants that it has the right and authority to grant the rights granted hereunder, that the consent of no other person or entity is required to enable use the Submission as described herein, and that such use will not violate the rights of any third party. Entrant waives all rights to legal recourse regarding use of the Submission, including likenesses therein. Entrant agrees to take responsibility for any and all claims arising out of use of the Submission as authorized herein. The rights granted herein shall inure to the benefit of the Peabody Organization, its licensees, successors, and assigns.

This Release constitutes the entire agreement and understanding between the parties regarding this subject matter hereof and may only be modified by a written document signed by all parties. The undersigned confirms that he/she has read and fully understood this document, and has not signed it in reliance on any statement or representation by the Peabody Organization or anyone acting on its behalf.
